- I. El Pleno del Consejo de la Judicatura acorde al artículo 97, fracciones II, III y VII de la Ley Orgánica del Poder Judicial del estado de Tabasco, tiene la facultad de expedir acuerdos generales para determinar la división del Estado en distritos y regiones judiciales, su número, su competencia territorial, su grado y, en su caso, la especialización por materia de los tribunales y juzgados que las leyes establezcan, así como establecer los criterios generales que sean necesarios para la adecuada distribución de los asuntos en los diversos distritos judiciales, para asegurar un adecuado ejercicio de la función jurisdiccional.

III. Ahora bien, la Constitución Federal en su artículo 17, establece en su segundo párrafo, que los Tribunales estarán expeditos para impartir justicia en los plazos y términos que fijen las leyes, emitiendo sus resoluciones de manera pronta, completa, imparcial y gratuita; así también instituye en el diverso 104 fracción II que los Tribunales de la Federación conocerán de todas las controversias del orden civil o mercantil que se susciten sobre el cumplimiento y aplicación de las leyes federales o de los tratados internacionales celebrados por el Estado Mexicano, el cual quedara sujeto a la elección del actor y cuando solo se afecten intereses particulares, podrán conocer de ellas los jueces y tribunales del orden común.

IV. Por el Acuerdo General 02/2013, emitido por el Consejo de la Judicatura, se creó el Juzgado de Oralidad Mercantil de Primera Instancia, mismo que entró en funciones el diecinueve de agosto de dos mil trece, cuya competencia territorial corresponde atender a todo el Estado de Tabasco, teniendo su sede en el Primer Distrito Judicial, Centro Tabasco, mismo que actúa con todas las facultades conferidas en el Código de Comercio, siendo el único juzgado especializado en dicha materia que actualmente opera en nuestro Estado.

V. De ahí que, sea necesario determinar los lineamientos a seguir, en los casos de impedimento, excusa o recusación del juez de oralidad mercantil, acorde a las hipótesis establecidas en el diverso 298 de la Ley Orgánica del Poder Judicial del Estado de Tabasco, y a su vez considerar que, en caso, de que acontezca



tal escenario deberá darse cumplimiento a lo previsto en el diverso 301 de la citada ley orgánica.

- VI.** Por ello, en observancia al derecho consagrado por el artículo 17 Constitucional, y para la buena marcha de la administración de justicia, se habilita a todos los juzgados civiles del Primer Distrito Judicial de Centro, Tabasco, para conocer y tramitar por todas sus etapas el procedimiento oral mercantil; por lo que cuando se actualice un impedimento, excusa o recusación por parte del juez especializado en oralidad mercantil, y se califique de legal, se deberá turnar el asunto de que se trate a uno de los Juzgados de Primera Instancia de naturaleza civil, del Primer Distrito Judicial, que determine este Consejo de la Judicatura a efectos de que lleve a cabo dicho procedimiento, conforme a las disposiciones legales procedentes.

Lo anterior, para efectos de respetar la voluntad de la parte actora de plantear su demanda ante el Tribunal del fuero común, de conformidad con lo establecido en el artículo 104 fracción II de la Constitución Federal.

Por lo expuesto, el Pleno del Consejo de la Judicatura del Poder Judicial del Estado de Tabasco expide el siguiente:

ACUERDO

Único. En caso de existir impedimento, excusa o recusación del titular del ~~único Juzgado de Oralidad Mercantil de Primera Instancia~~, en el Estado,

será el Juez de Primera instancia de naturaleza civil, del Primer Distrito Judicial, que determine el Consejo de la Judicatura, quien deberá conocer del juicio oral mercantil planteado, el cual resolverá conforme a las disposiciones legales procedentes.

Transitorios

Primero. El presente acuerdo entrará en vigor el mismo día de su aprobación por el Pleno del Tribunal Superior de Justicia del Estado.

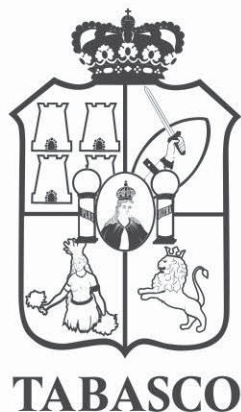
