### ACUERDO

Con fundamento en el artículo 6 de la Ley de Coordinación Fiscal, que prevé que las Entidades Federativas deberán publicar trimestralmente, las participaciones federales que son transferidas a los municipios y en su caso el ajuste realizado al término de cada ejercicio fiscal, para dar cumplimiento a esta disposición, se ordena la publicación correspondiente a los **Anexos de Participaciones Federales y el Fondo de Estabilización de los Ingresos de las Entidades Federativas (FEIEF) ministrados a los municipios en el Tercer Trimestre del Ejercicio Fiscal 2023, así como las cifras de recaudación para los Fondos Predial y Recaudatorio del Cálculo y Distribución de las Participaciones**, los cuales se encuentran establecidos en los artículos 11 y 12 de la Ley de Coordinación Fiscal y Financiera del Estado, firmados por el M.A. Juan Francisco Cabrera Gutiérrez, Subsecretario de Ingresos de la Secretaría de Finanzas.


